Waiver and Release of Liability: As parent or legal guardian of the student named above, I understand and acknowledge the risks

associated with the sport of gymnastics, cheerleading, and dance and other related activities, including paralysis and other catastrophic injury, as well as medical expenses and damages that may result or be associated with the sport of gymnastics/cheer and related activities as referenced above. Being aware of the risks involved with participating in gymnastics/cheer and the related activities referenced above, the undersigned, for himself/herself and the student named above and for the heirs, legal representatives and assigns of both, voluntarily assumes the risk of participating in gymnastics/cheer and the related activities referenced above. The undersigned, for himself/herself and the student named above, and for the heirs, legal representatives and assigns of both, do hereby release and discharge MEGA Gymnastics, LLC and its officers, directors, agents and employees and their respective heirs, legal representatives, successors in interest and assigns, from any and all liability to the undersigned and the student named above, and to the heirs, legal representatives and assigns of each from any and all actions, claims, demands, loss or damage and any claims for such losses or damage on account of injury to the student's person or property, to include the student's death, whether caused by the negligent or intentional act of those released hereunder or otherwise in any way resulting, directly or indirectly, from the student's participation in gymnastics/cheer and the related activities. The undersigned further agrees that the undersigned and the student and the heirs, legal representatives and assigns of both shall not make a claim against, sue, attach the property of or prosecute MEGA Gymnastics, LLC or its officers, directors, agents or employees or their respective heirs, legal representatives, successors in interest and assigns, for any injury or damage resulting from the intentional, negligent or other acts, however caused, of those released hereunder. For himself/herself and the student and for the heirs, legal representatives and assigns of either, the undersigned further agrees to indemnify and hold harmless those released hereunder and each of them from any loss, liability, damage or costs they may incur as the result of the student's participation in gymnastics/cheer and related activities referenced above whether caused by the intentional, negligent or other acts of those released hereunder or otherwise. The undersigned and the student hereby assume full responsibility for the risk of bodily injury, death or property damage due to the intentional or negligent act of those released hereunder or otherwise while participating in gymnastics or related activities.

Minor's Release Authorization: Without compensation to me or the student, I hereby grant to MEGA Gymnastics, LLC the absolute right and permission to copyright, publish, and use photographic portraits, pictures, or videos of the minor for use through reasonable promotion of gymnastics, cheer and sports conducted by MEGA Gymnastics, LLC. I hereby waive any right that I or the minor may have to inspect or approve the finished media material as long as the matter is within reason and is not deemed to be socially inappropriate for use of the minor or student.

Medical Release: I Hereby authorize and give my consent to MEGA Gymnastics, LLC., including any of its instructors or other authorized employees to provide emergency medical care and to give authority to any emergency unit, hospital or doctor to render immediate aid as might be required for the treatment of the above named student in the event of any emergency either on the premises of MEGA Gymnastics & Cheer or during the course of any sports event involving the student as a MEGA Gymnastics & Cheer participant.

Verification and Release: As legal parent, guardian or responsible party of this student, I hereby verify by my signature below that I accept the conditions of the waiver, release and indemnification; and furthermore I permit my child to participate in the events provided by MEGA Gymnastics and Cheer.

The undersigned expressly agrees that this document is intended to be as broad and inclusive as is permitted by the laws of the State of South Dakota and if any portion thereof is held invalid the balance shall, notwithstanding, continue in full force and effect.

I have carefully read this document and fully understand its contents. I am fully aware that this is a waiver and release of liability and an assumption of the risk by me on behalf of the student; it is a contract between me, the student, and MEGA Gymnastics, LLC.
